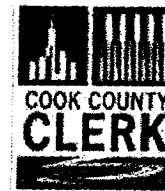

ORDINANCE NO. 2014-4
AN ORDINANCE FOR THE LEVY OF TAXES FOR THE POSEN PARK DISTRICT
FOR THE FISCAL YEAR BEGINNING MAY 1, 2014 AND ENDING APRIL 30, 2015

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE POSEN PARK DISTRICT, COUNTY OF COOK AND STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1

Pursuant to authority vested in them by Article Five of the Park District Code, the Commissioners of the Posen Park District in meeting assembled do hereby find and declare that there will be required to be raised by general taxation the amounts hereinafter set forth to be levied upon all the taxable property in the said Posen Park District, in order to meet and defray all the necessary expenses and liabilities of the Posen Park District as required by statute or voted by people. The sum of One Hundred Sixty One Thousand Two Hundred Ninety Nine (\$161,299) Dollars in the total of that part of the appropriations hereto legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of May, 2014 and ending the 30th day of April, 2015, by the Posen Park District, Posen, Illinois for all Corporate Purposes of said Park District and for purposes of providing for a Recreation Fund, Joint Recreational Programs for the Handicapped Fund, Audit Fund, Workers Compensation Fund, Liability Fund and Social Security Fund, is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal years, as set forth below:

- I. **General Corporate**: The amount to be raised by Tax Levy for General Corporate Purposes (Authority 70 ILCS 1205/5-1): **\$65,192.00**
- II. **Recreation**: The amount to be raised by Tax Levy for the Purpose of Planning, Establishing and Maintaining Recreational Programs (Authority 70 ILCS 1205/5-2): **\$51,823.00**
- III. **Joint Recreational Programs for the Handicapped**: The amount to be raised by Tax Levy for the Purpose of Funding the District's Share of the Expenses of Providing Recreational Programs for the Handicapped (Authority 70 ILCS 1205/5-9): **\$25,000.00**
- IV. **Audit**: The amount to be raised by Tax Levy for Audit Expenses (Authority 50 ILCS 310/9): **\$2,048.00**
- V. **Workers Compensation**: The amount to be raised by Tax Levy for the purpose of the payment of judgments, settlement of workers compensation matters, as well as all other powers allowed by statute (Authority 745 ILCS 10/9-102): **\$3,185.00**
- VI. **Liability Insurance**: The amount to be raised by Tax Levy for Comprehensive Liability Insurance (Authority 745 ILCS 10/9-107): **\$10,126.00**

VII. Social Security: The amount to be raised by Tax Levy for the purpose of meeting the cost of participation in the Federal Social Security Insurance Program (Authority 40 ILCS 5/21-110):
\$3,925.00

SECTION 2

That the total amount of One Hundred Sixty One Thousand Two Hundred Ninety Nine (\$161,299) Dollars ascertained as aforesaid, be, and the same is hereby levied and assessed on all property subject to taxation within the Posen Park District according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.

SECTION 3

That there is hereby certified to the County Clerk of Cook County, Illinois, the several sums aforesaid constituting One Hundred Sixty One Thousand Two Hundred Ninety Nine (\$161,299) Dollars which said total amount the said Posen Park District requires to be raised by taxation for the current fiscal year of said Park District, and the Secretary of said District is hereby ordered and directed to file with the County Clerk of said County on or before the time required by law, a certified copy of this Ordinance.

SECTION 4

This Ordinance shall take effect and be in full force and effect immediately on or after its passage, approval, and publication as may be required by law.


