

ORDINANCE NO. 2016-2

**AN ORDINANCE ESTABLISHING THE
PREVAILING WAGE RATE FOR
THE POSEN PARK DISTRICT**

WHEREAS, the State of Illinois has enacted "An Act regulating wages of Laborers, Mechanics and other Workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, and now described as "The Prevailing Wage Act", cited as 820 ILCS 130/0.01 - 130/12; and

WHEREAS, section 820 ILCS 130/9 of the Act requires each public body including the POSEN PARK DISTRICT during the month of June in each calendar year to investigate and ascertain the prevailing rate of wages as defined in said Act for Laborers, Mechanics and Other Workers in the locality of the POSEN PARK DISTRICT for those employed in performing construction of public works, for the POSEN PARK DISTRICT.

WHEREAS, "The Prevailing Wage Act", 820 ILCS 130/9 requires the Park District to file a certified copy of their investigation and determination with the Department of Labor.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF COMMISSIONERS OF THE POSEN PARK DISTRICT AS FOLLOWS:

SECTION 1: To the extent and as required by "An Act regulating wages of Laborers, Mechanics and Other Workers employed in any Public Works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for Laborers, Mechanics and Other Workers engaged in construction of public works coming under the jurisdiction of the POSEN PARK DISTRICT is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook County area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the POSEN PARK DISTRICT to the extent required by the aforesaid Act.

SECTION 3. The POSEN PARK DISTRICT Secretary shall publicly post or keep available for inspection by any interested party in the main office of the POSEN PARK DISTRICT, this determination of such prevailing rate of wages.

SECTION 4. The POSEN PARK DISTRICT Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5. The POSEN PARK DISTRICT Secretary shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

SECTION 6. The POSEN PARK DISTRICT Secretary shall cause to be published in a newspaper of general circulation within the area a notice of its determination, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.

SECTION 7. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

SECTION 8. This Ordinance shall be in full force and effect from and after passage and publication as allowed by law.

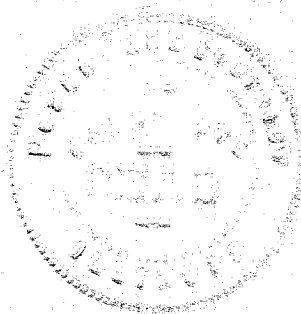

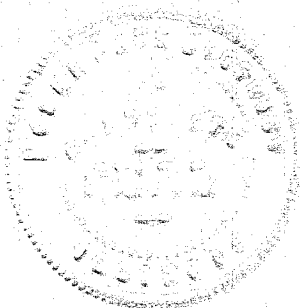
